Timothy A. Mousseau is a Professor of Biological Sciences at the University of South Carolina and the Co-Director of the Chernobyl + Fukushima Research Initiative. Past positions include Dean of the Graduate School and Associate Vice President for Research at the University of South Carolina, and Program Officer for Population Biology at the US National Science Foundation. He is a leading authority concerning the impacts of radioactive fallout from the Chernobyl and Fukushima

disasters on natural populations of animals, plants, and microbes. He has written or edited 11 books and published more than 200 scientific papers. His research has been featured in the *New York Times*, *The Economist*, CBS TV's *60 Minutes*, *Scientific American*, the BBC, CNN, PBS, and many other media outlets. He is a member of the International Union of Radioecology, the American Nuclear Society, and the New York Academy of Sciences.
