Peter Albrecht is a senior researcher at the Danish Institute for International Studies, Copenhagen. He is the co-author of several books on security in Sierra Leone, including *Reconstructing Security after Conflict: Security Sector Reform in Sierra Leone* (Palgrave Macmillan, 2011) and *Securing Sierra Leone, 1997–2013: Defence, Diplomacy and Development in Action* (Taylor and Francis/RUSI, 2014), and co-editor of *Policing and the Politics of Order-Making* (Routledge, 2015). His work is published in several journals, including *Journal of Modern African Studies*, *African Studies Review* and *Ethnos*.

Matthew Allen works at the interstices of geography, political science and anthropology. Matthew's research interests include extractive resource industries and violence, agrarian change and rural development, and state–society relations. M. Anne Brown is a teacher and researcher at the Centre for Global Research, RMIT University, Melbourne. Anne's research and practice interests focus on political community across division, peacebuilding and state formation in heterogeneous states, social dialogue processes, social resilience and the interface of practice and theory.
