Hon S Chan is a professor in the Department of Public Policy, City University of Hong Kong. His research focuses on civil service reforms, cadre personnel management and performance evaluation and management in China. He has published extensively in major journals in the field.

José Chiu-C Chen is Professor and Chair at the Department of Public Management and Policy, Tunghai University, where his teaching and research are focused on non-profit management, personnel administration reform and urban governance. Professor Chen received his PhD from National Chengchi University, Taiwan. He was elected as the president of Taiwan Association for Schools of Public Administration and Affairs (TASPAA) in 2019. He has served as a committee member or consultant to various government agencies, non-profit organisations and social enterprises.

Zitao Chen is a PhD candidate at the School of International and Public Affairs, Shanghai Jiao Tong University. His research interests are in public policy analysis and government performance management.

David Gilchrist is an accountant and economic historian within the University of Western Australia Business School. Over her career she has served in the senior executive service in a number of agencies and departments including Customs, Immigration and Agriculture. She has also served as Norfolk Island Public Service Commissioner.

Yi-Huah Jiang is the Bauhinia Chair Professor, Institute of Strategic and International Affairs at National Chung Cheng University, Taiwan. He received his BA and MA from National Taiwan University, and PhD in political science from Yale University. Before joining National Chung Cheng University, he was professor in the Department of Public Policy, City University of Hong Kong. He was also a visiting scholar at Cambridge University, Columbia University, Harvard University and Stanford University. Jiang's academic interests lie in political philosophy, democratic theory, national identity, general education and Taiwanese politics.

Helen K Liu is Associate Professor in the Department of Political Science and the Graduate Institute of Public Affairs, National Taiwan University (NTU). Before joining NTU, she worked in the Department of Politics and Public Administration, University of Hong Kong. She has served as an emerging scholar at the Urban Institute, Washington DC; a summer fellow in the RGK Center on Philanthropy, University of Texas at Austin; and a visiting scholar at Peking University. Her research interests are in inter-organisational networks, social service provision, collaborative governance, crowdsourcing adaptation and non-profit management.

Fanrong Meng is Professor at the School of Public Policy and Administration and Executive Director of Research at the Center for Performance Management, Xi'an Jiaotong University. Her teaching and research are focused on performance management in public sectors, environmental governance, science and technology policy and management.

Meili Niu is a professor in the School of Government, Sun Yat-sen University, and the Deputy Director of the Center for Chinese Public Administration Research. Her research focuses on public budgeting and

finance. She has over 10 years' experience working as a consultant and adviser to Chinese governments and congresses on budgetary reforms and policy evaluation. She serves on the editorial board of several academic journals, including the *Journal of Public Administration* (Chinese); the *Journal of Public Budgeting, Accounting & Financial Management*, *Perspectives on Public Management & Governance*, and *State and Local Government Review*.

Andrew Podger is Honorary Professor of Public Policy at The Australian National University. He was previously a senior public servant in the Australian Government, with roles including Public Service Commissioner, secretary of the Department of Health and Aged Care, secretary of the Department of Housing and Regional Development and secretary of the Department of Administrative Services. He was also national president of the Institute of Public Administration Australia from 2004 to 2010.

Bennis Wai Yip So is Head and Professor at the Department of Public Administration, National Chengchi University in Taiwan. His recent research interests are in civil service systems in East Asia, and performance management of the public sector. He has published in *Australian Journal of Public Administration*, *Public Management Review*, *China Quarterly*, and *Asia Pacific Journal of Public Administration*.

Tsai-tsu Su is Professor and Director at the Graduate Institute of Public Affairs, National Taiwan University, where her teaching and research are focused on public budgeting, administrative reform and policy analysis. Professor Su received her PhD from Carnegie Mellon University, Pittsburgh, and taught at the State University of New York at Stony Brook before returning to Taiwan. She has served as a committee member or consultant to various government agencies and was the president of the Taiwan Association for Schools of Public Administration and Affairs for two terms.

John Wanna is Emeritus Professor in both the School of Politics and International Relations, College of Arts and Social Sciences, The Australian National University; and the School of Politics and International Relations at Griffith University. He was formerly the Sir John Bunting chair in public administration with the Australia and New Zealand School of Government until 2019.

Mike Woods is Professor of Health Economics at the University of Technology Sydney and a visiting scholar at The Australian National University. His research interests are in health system reform, aged care and economic reform. He was formerly the deputy chairman of the Australian Productivity Commission and was presiding commissioner on more than 20 national inquiries into aspects of economic reform.

Jiannan Wu is Distinguished Professor and Executive Vice Director of the China Institute of Urban Governance at Shanghai Jiao Tong University.
