

Appendix 4: Academic (and Quasi-Academic) Coverage of Manning Clark's Life and Work (1993–2021)

The names of authors who wrote about Manning Clark and were published in *Quadrant* have been rendered in bold. Peter Ryan's references to Clark in his *Quadrant* column are itemised in Appendix 3.

Apart from some of the *Quadrant* entries, this Appendix is confined to items where Clark is discussed in his own right or else receives noteworthy mention. Passing remarks on a point of substance are also included. It excludes newspaper articles and obituaries. The contents of this Appendix demonstrate the continuing ubiquity of Manning Clark as someone of importance and relevance, such was the number and variety of his friends (and enemies!), the many contexts in which he appeared and the sheer range of his activities.
