Jonathan Boston

Jonathan Boston is Professor of Public Policy and Director of the Institute of Policy Studies at the School of Government, Victoria University, New Zealand. Professor Boston has published over 25 books and 180 journal articles and book chapters in the fields of public management, tertiary education, research funding, social policy, comparative government, New Zealand politics and climate change policy.

The Hon. Aart de Geus

As Deputy Secretary-General of the OECD, Aart de Geus is responsible for the organisation's agenda in the areas of employment, labour, social affairs, education, public governance and territorial development. He is a Dutch citizen and served as the Minister of Social Affairs and Employment in the Netherlands government from 2002 until 2007.

Janet Dore

Janet Dore is CEO of Victoria's Transport Accident Commission (TAC). She is an entrepreneurial executive with extensive experience in local council governance, having been CEO of Newcastle City Council prior to joining the Transport Accident Commission in 2007.

The Hon. Sir Roger Douglas

Sir Roger Douglas MP served as New Zealand's Minister of Finance between 1984 and 1988, presiding over an era of market-led restructuring of the New Zealand economy, which would come to be known throughout the world as 'Rogernomics'. After an 18-year hiatus, Sir Roger re-entered New Zealand's Parliament in 2008 as a 'list MP' for the ACT Party.

The Hon. Bill English

Bill English MP is the Minister of Finance and Infrastructure and Deputy Prime Minister in the John Key-led National government in New Zealand. He was first elected to New Zealand's parliament in 1990 and has served as Minister of Health, Minister of Finance and Minister of Revenue in previous National governments, and held senior posts in opposition.

Allan Fels

Professor Allan Fels served as chairman of the Australian Competition and Consumer Commission (ACCC) from its inception in 1995 until 2003. Upon his retirement from the ACCC, Professor Fels became the inaugural Dean of the Australia and New Zealand School of Government (ANZSOG). He has been a much sought-after policy advisor to federal and state governments of different political persuasions.

Paul 't Hart

Paul 't Hart is Professor of Public Administration at Utrecht University in the Netherlands. From 2005 until 2010 he was Professor of Political Science at the ANU, convening ANZSOG's Towards Strategic Leadership program and a course on leading public sector change within the school's MPA program.

Paul Kelly

One of Australia's most accomplished political commentators, Paul Kelly is editor-at-large of *The Australian* newspaper. His best-selling titles on Australian politics include *The March of Patriots: The Struggle for Modern Australia*; *100 Years: The Australian Story*; *The End of Certainty*; and *The Hawke Ascendancy*. Paul Kelly is an active member of the Academy of the Social Sciences in Australia.

The Hon. Michael Kirby

When he retired from the High Court of Australia in 2009, Michael Kirby was Australia's longest serving judge, having been first appointed as a Deputy President of the Australian Conciliation and Arbitration Commission in 1975, and later serving in the Federal Court of Australia, the New South Wales Court of Appeal and the High Court of Australia. Since his judicial retirement, Michael Kirby has been a member of the international Eminent Persons Group which is investigating the future of the Commonwealth of Nations.

William E. Kovacic

William E. Kovacic has served on the Federal Trade Commission of the United States since 2006, having previously worked for the Commission from 1979 until 1983. Before serving on the Commission, Professor Kovacic taught law at George Washington and George Mason universities.

Evert A. Lindquist

Evert A. Lindquist is Professor at the School of Public Administration at the University of Victoria, Canada, serving as its Director since 1998. In 2010 Professor Lindquist held the ANU/ANZSOG Chair in Applied Public Management at the Australian National University.

Ken Matthews

Ken Matthews served as the Chair, CEO and one of seven government-appointed commissioners of the National Water Commission from 2005 until his retirement in 2010. A career public servant, he was previously Secretary of the Department of Agriculture, Fisheries and Forestry and Secretary of the Department of Transport and Regional Services.

Andrew Metcalfe

Andrew Metcalfe is Secretary of the Department of Immigration and Citizenship, having been appointed to the position in 2005, and reappointed in 2009. Between 2002 and 2005 he served as Deputy Secretary of the Department of Prime Minister and Cabinet, having joined the Australian Public Service in 1980.

Rob Moodie

Professor Rob Moodie is Chair of the Nossal Institute for Global Health at the University of Melbourne, having previously been CEO of VicHealth between 1998 and 2007. Professor Moodie is Vice-President of the International Union of Health Promotion and Education, and a member of the Asia-Pacific Leadership Forum on HIV/AIDS.

Mary Ann O’Loughlin

Mary Ann O’Loughlin is Executive Councillor and Head of the Secretariat of the COAG Reform Council. Between 2000 and 2008 Ms O’Loughlin was Director of the economics and public policy consultancy firm, Allen Consulting Group. She has also previously been a senior advisor to Prime Minister Keating, and held a number of senior positions in the Australian Public Service.

Eric M. Patashnik

Eric M. Patashnik is Professor of Politics and Public Policy and Associate Dean of the Frank Batten School of Leadership and Public Policy at the University of Virginia. Professor Patashnik’s research on US public policy has focused on the interaction of institutions, agendas and interest groups in the development of major legislation; his most recent book is *Reforms at Risk: What Happens After Major Policy Changes Are Enacted*, winner of the Brownlow Book Award for outstanding contributions to the literature of public administration.

Jeremy Pope

Jeremy Pope is a New Zealand Human Rights Commissioner, barrister and solicitor of the Supreme Court of New Zealand, and barrister-at-law with the English bar. Jeremy Pope co-founded Transparency International, and Tiri, a London-based NGO striving for sustainable development through increased integrity in government and business.

Stephen Sedgwick

Stephen Segwick became the Australian Public Service Commissioner in 2009 after a period as Professor and Director of the Melbourne Institute of Applied Economic and Social Research at the University of Melbourne. He has had a distinguished career in the public sector, having served as the Secretary of the Commonwealth Departments of Finance, Employment and Education between 1992 and 2002.

The Hon. Lindsay Tanner

Lindsay Tanner served as Minister of Finance and Deregulation from 2007 until 2010 in the Rudd and Gillard governments. Upon retirement from politics at the 2010 federal election, he was appointed a Vice Chancellor's Fellow and Adjunct Professor at Victoria University, Australia, and as a special adviser to financial firm Lazard Australia.

John Wanna

Professor John Wanna holds the Sir John Bunting Chair of Public Administration at the Australian National University, a research chair established by ANZSOG in partnership with the ANU. He is also Professor of Politics and Public Policy at Griffith University, and formerly principal researcher with the Centre for Australian Public Sector Management and the Key Centre in ethics, Law, Justice and Governance at Griffith University.
