Nicholas Aroney is a professor of constitutional law and a fellow of the Centre for Public, International and Comparative Law at the University of Queensland. His books include *The Constitution of a Federal Commonwealth: The Making and Meaning of the Australian Constitution* (Cambridge, 2009), *The Future of Australian Federalism* (Cambridge, 2012), *The Constitution of the Commonwealth of Australia: History, Principle and Interpretation* (Cambridge, 2015), *Courts in Federal Systems: Unitarists or Federalists?* (Toronto, 2017) and *The Routledge Handbook of Subnational Constitutions and Constitutionalism* (Routledge, 2021).
