Simon Avenell is Associate Professor in History and Associate Dean (HDR) in the College of Asia and the Pacific, The Australian National University. He is the author of *Making Japanese Citizens: Civil Society and the Mythology of the Shimin in Postwar Japan* (University of California Press, 2010) and *Transnational Japan in the Global Environmental Movement* (University of Hawai'i Press, 2017).

Adam Broinowski is a visiting research fellow at the School of Culture, History and Language at the College of Asia and the Pacific, The Australian National University. His monograph *Cultural Responses to Occupation in Japan: The Performing Body During and After the Cold War* was published with Bloomsbury Academic in 2016.

Cho (Han) Haejoang is Emeritus Professor of Cultural Anthropology, Yonsei University and Director of the Haja Center (Seoul Youth Factory for Alternative Culture). Her works in Korean include *Men and Women in South Korea* (1988), *Reflexive Modernity and Feminism* (1998) and *Back to the Classroom: Reading Text and Reading Everyday Lives in the Neoliberal Era* (2009).

He researches the role of art in modern and contemporary China–Japan relations, and networks of artistic activism across East Asia. He is co-editor of *Asia through Art and Anthropology: Cultural Translation Across Borders* (Bloomsbury, 2013). His recent curatorial projects include ‘Zhang Peili: from Painting to Video’ (2016) and ‘Between: Picturing 1950–60s Taiwan’ (2015), both held in the CIW Gallery.

Ou Ning is a multidisciplinary practitioner from China who now teaches at the Columbia University Graduate School of Architecture, Planning and Preservation in New York. He lived in a small village in Anhui Province and founded the Bishan Commune (2011–2016) and School of Tillers (2015–2016), to join the new rural reconstruction movement in China, and is known for urban research and documentary projects such as *San Yuan Li* (2003) and *Meishi Street* (2006).

Tessa Morris-Suzuki is Distinguished Professor of Japanese History and Australian Research Council Laureate Fellow in the College of Asia and the Pacific, The Australian National University.

Eun Jeong Soh researches health and marketplace economy in North Korea, and was a Postdoctoral Research Fellow in the College of Asia and Pacific, The Australian National University, from 2014 to 2016.

Shoko Yoneyama is Senior Lecturer in the Department of Asian Studies, University of Adelaide. Her research interests include the politics and philosophy of education, alternative education, organic farming, food and environment, and alternative social movements, and her publications include *The Japanese High School: Silence and Resistance* (Routledge, 1999).
